Dear Jeremy,

I have pleasure in inviting you to join the WIPO Arbitration and Mediation Center's List of Neutrals.

As you may know, the Center was established in 1994 to promote the resolution of intellectual property disputes through arbitration and mediation. To achieve this objective, the Center has created – with the active involvement and advice of many of the foremost ADR and intellectual property practitioners and scholars – the WIPO Mediation, Arbitration and Expedited Arbitration Rules.

The WIPO Rules are appropriate for all commercial disputes. However, they contain provisions on confidentiality and technical and experimental evidence that are of special interest to parties to intellectual property disputes. In addition, the WIPO Rules attempt to bridge gaps between different legal cultures by providing procedural solutions that combine civil and common law approaches. They also provide for expedited arbitration, a procedure that is especially appropriate where, due to the circumstances of the dispute or the monetary amount at stake, a more rapid settlement is required.

The WIPO Rules are designed to allow parties the greatest freedom to tailor the arbitration or mediation procedure to the nature of their dispute. To mention only one example, the WIPO Rules allocate primary responsibility for the appointment of neutrals to the parties, allowing them to select persons whose professional experience and technical expertise are germane to their dispute. Even where, in an arbitration, the Center is called upon – by default – to appoint a neutral, the autonomy of the parties is enhanced through the "list procedure", under which the selection is ultimately based on the parties' own ranking of candidates proposed by the Center.

The Center has drafted model contract clauses and submission agreements through which disputes can be referred to mediation or arbitration under the WIPO Rules. Where the Center is asked to administer the procedure, its multilingual case managers employ the most advanced information technology and online resources to provide effective support to both parties and neutrals.

The WIPO Rules and the Center's role as an efficient administrator of ADR procedures are attractive to parties. However, the Center's reputation for excellence is, above all, a result of its list of outstanding neutrals. The WIPO List includes approximately 1,000 arbitrators and mediators from 70 countries. It makes available to parties a broad and deep reservoir of expertise, covering the entire legal and technical spectrum of intellectual property and ADR.

As a result of these strengths and of the growing number of international intellectual property disputes being resolved through ADR procedures, demand for the Center's services has increased materially. The Center's current caseload includes arbitrations and mediations that are being conducted in three languages, involving parties from nine countries. In addition to making appointments under the WIPO Rules, the Center also recommends and appoints neutrals for proceedings that are not conducted under the WIPO Rules.

I enclose a copy of the WIPO Rules. The fees payable to WIPO Neutrals are described in the WIPO Rules and at

I very much hope that you will accept to become a member of the Center's List of Neutrals and join our efforts to provide first-rate dispute resolution services. Your involvement would greatly enhance the stature of the Center and our ability to offer parties the best possible choice of panelists.
